8.1 (Agenda 1) Apologies for Absence

Apologies were received from Cllr Harman who had work commitments.

Members **RESOLVED** to accept his apologies.

8.2 (Agenda 2) Chairman's Remarks

Members were reminded of the council's code of conduct and the requirement to make Declarations of Pecuniary Interest.

8.3 (Agenda 3) To receive any declarations of interest

8.4 (Agenda 4) Public participation.

- 1. The meeting heard from the Residents Against Wandon End Action Group:
 - a. A presentation was given with key points on the proposal.
 - b. Dates for two drop in sessions to assist the community in responding to the application were given as: Saturday 11th February 11am 2pm, and Monday 13th February 4pm 6pm. Both sessions will be held in the Village Hall, Chapel Road, Breachwood Green.
- 2. Cllr David Barnard addressed the meeting and offered his support to the Residents Against Wandon End Action Group
- 3. Cllr Strong addressed the meeting and offered some advice on how to respond to planning applications.


The Chair proposed to move Agenda Item 6 Planning up the agenda. Members **AGREED** to move it up the agenda.

The Chair proposed to suspend Standing Order 3 to allow for longer and more free discussion of Agenda Item 6ai 22/03231/FP Land North East of Wandon End. Members **AGREED** to this proposal.

8.5 (Agenda 6) To receive and consider responses to planning applications

- 1. 22/03231/FP, Land North East Of Wandon End Hertfordshire.
 - a. Residents in attendance raised concerns and asked questions regarding the proposal.
 - b. The Chair read out a letter sent to KWPC from Evolution Power outlining the changes made to the proposal since the Consultation, and outlining Community Benefits which includes:
 - Community Fund: £15,000 per annum (inflation linked) that will be made available for the 40 year life of the project to be used at the Parish Council's discretion,
 - ii. Rooftop Solar Proposal: for approximately 30-40 households most impacted by the development.

The Chair proposed to reinstate Full Standing Orders. Members AGREED to this proposal.

- 2. Members **AGREED** to object to the proposed development at Land North East Of Wandon End Hertfordshire. Reasons for objection were discussed and the clerk will draft a response.
