





One contractor has already been out to look at it and advises we should get something done in the next month or we risk losing the kitchen ceiling where the roof is particularly bad.

Complaints of a historic hedgerow having been destroyed in BWG. Queries over whether it comes under historic hedgerow. Can be reported to planning enforcement if anyone believes there is an issue.

11. Stopsley Sharks - Corner Posts

Message from Stopsley Sharks re the corner posts:

Firstly, please allow me to apologise for not obtaining permission for the corner flag sleeve installation. This was a breakdown of communication internally at the club and not our intention to create any disappointment or frustration at the Parish.

One of our committee members went over this afternoon and and back filled all flag holders protruding from the ground. It is usual that once the ground is broken into, back filled holes can have some "sinking" around the area which is what happened here to the sleeves.

The plan is that all of the sleeves will be shortened to below ground level, an insert fabricated with artifical grass on top which will cover the sleeve fully and sit at ground level.

Once again we would like to apologise for the breakdown in communication and any problems caused. Going forward we will ensure that we have written permission before undertaking any ground work at the recreation ground.
